

In this past year, Cooley was able to provide more than 50% of its students with scholarship assistance. We placed 780 students into externship positions around the nation. Students in our clinics represented literally hundreds of clients who could not otherwise obtain services. Our skills competition teams performed wonderfully, one coming away with an ABA national championship. We expanded our library into one of the nation's largest. Our Michigan first-time bar exam pass rate for 2010 was an outstanding 84.2%, and on the February 2011 bar we finished second among the Michigan law schools with a score of 85.9%.

As you can tell from just these few facts, your belief in Cooley is paying off. I assure you that your continued support is invaluable to Cooley's students and to the Law School's ability to meet its mission.
